Graduate Education and Research Committee Terms of Reference

3. The GERC will consider and report back on any major graduate education and research issues including admission regulations or requirements arising from regular meetings of the Graduate Chairs Committee, external reviews of graduate departments, or other concerns referred to it by members of the Committee or the Speaker of Faculty Council.
4. The GERC will advise Faculty Council on any matters related to governance of the graduate programs of the Faculty.
5. The GERC does not have responsibility for matters pertaining to Professional Development and/or the administration of non-degree Professional Development courses.
6. Graduate appeals will continue to be dealt with according to SGS guidelines and are not within the responsibilities of the GERC.
